IT CHANGES MUCH MORE THAN ABORTION

1 This initiative creates an expansive legal right to "reproductive freedom" that goes far beyond current Idaho law and would dramatically reshape how abortion and reproductive healthcare are regulated.

IT ELIMINATES IDAHO'S PHYSICIAN-ONLY REQUIREMENT.

2 Current Idaho law requires abortions to be performed by licensed physicians. This initiative removes that protection and would allow any healthcare provider - not just physicians - to perform abortions.

IT ELIMINATES PARENTAL CONSENT AND REMOVES AGE RESTRICTIONS.

3 Today, Idaho parents have legal rights when their minor daughter seeks an abortion. This initiative removes those protections and allows minors to obtain abortions without parental knowledge or consent.

IT ALLOWS ABORTION UNTIL 9 MONTHS OF PREGNANCY IF A WOMAN WISHES.

4 This initiative allows abortion throughout all nine months of pregnancy, for any reason, with no protections for the preborn child.

IDAHO ALREADY PROTECTS WOMEN IN MEDICAL EMERGENCIES.

5 Treatment for miscarriage, ectopic pregnancy, and life-threatening complications remain legal in Idaho. Physicians can and do provide necessary medical care when a mother's life is endangered.

WOMEN NEED MORE SUPPORT - NOT MORE ABORTION

6 Every day we meet women who believe abortion is their only option. What they often need is housing, medical care, financial help, parenting support, adoption information, baby supplies, counseling, and community.

WE KNOW WHAT WOMEN ARE FACING

7 We serve women from all walks of life - victims of domestic violence, homeless mothers, college students, teenagers, and women facing impossible circumstances. Compassionate care and practical support save lives.

EVERY HUMAN LIFE HAS VALUE.

8 From conception to natural death, every human being has inherent dignity and worth. Both mother and child deserve protection.

THIS VOTE WILL SHAPE IDAHO FOR GENERATIONS.

9 The decisions voters make this November will affect families, medical practice, parental rights, and the legal protections afforded to unborn children for generations to come.

Can doctors treat miscarriages?

Yes. Miscarriage treatment remains legal in Idaho.

Can doctors treat ectopic pregnancies?

Yes. Ectopic pregnancy treatment remains legal in Idaho.

Can doctors save a mother's life?

Yes. Idaho law allows physicians to provide emergency medical care when a mother's life is endangered.

Why does parental consent matter?

Parents are responsible for their children. We believe they should remain involved in significant medical decisions affecting their minor daughters.
